Insurance:

- Proof of insurance required prior to, or on arrival (minimum of NZD \$5,000,000 Third Party Coverage required)

Notice Period:

- Long term licence agreements require 30 days' notice to terminate.
- Visitor and Casual berths require 48 hours' notice to shorten or cancel, extensions are subject to availability
- Visitor / Casual berths limited to three months out of any 12 unless otherwise approved by management

Early arrivals and late departures

- All agreements start and finish at 12pm.
- Early arrivals and late departures to be arranged with marina office. Additional charge may apply.

Boat Length:

- All fees and charges relating to the length of a vessel; shall be based on the LOA "length overall". This shall be determined as being from bow to stern including all fixtures such as bowsprits, self-steering gear, davits, dinghies etc.
- The minimum charge shall be based on an 8-metre vessel
